

ENROLLMENT FORM

Before enrolling in Curative Care Center's program, it must be determined that you are eligible to receive such services.

Eligibility includes:

Positive HIV, AIDS, or Hepatitis status

Seeking HIV Prevention Services

Once determined eligible for enrollment you are authorizing Curative Care Center to oversee your compliance within the linked medical treatment facility. If compliance is not upheld, you will no longer be eligible to remain in Curative Care Center's program. Enrollment in PrEP program will require a review every 3-6 months to determine if you are still eligible to remain in program.

Non-Compliance includes but is not limited to:

- Failure to adhere to medication regimen sent forth by treating physician. This includes refusal to fill or pick up medications.
- Failure to adhere to appointments with treating physician.
- Failure to complete testing or keep appointments such as: blood work, diagnostic testing, appointments to referred physicians.
- If for any reason you are discharged from any office, physician, or facility your enrollment will be reviewed.
- Providing false or fraudulent information.

Upon enrollment, you are agreeing to adhere to guidelines set forth by Curative Care Center and treating physician. Curative Care Center's goal is for our clients to remain compliant with recommended treatment, which contributes to a healthy and safe lifestyle. By enrolling, you are agreeing to utilize one of the contracted pharmacies to fill HIV prevention, HIV/AIDS, and Hepatitis medications prescribed by treating physician.

During Active enrollment, you will receive medical care (from treating physician) and medications pertaining to eligible diagnosis at no cost. If you receive a bill for routine blood work, please forward the invoice directly to the Curative Care Center at: info@curativecarecenter.com for further review. If you fail to do so, we will not be aware of the invoice or be responsible if it is sent to collections. Service date must be congruent with active enrollment status.

We are able to assist with transportation for medical related services, health insurance enrollment and premium payment (if qualified) up to a predetermined amount. Individuals in PrEP program will be responsible for all copays except for those involving preventative treatment, laboratory, and diagnostic testing ordered by treating physician.

For assistance beyond the listed expenses above, Curative Care Center requires all clients to be enrolled in the program for at least 45 days. Additional financial assistance is limited to those with a positive HIV/AIDS status. During this time, the client must be fully compliant in our program. If additional financial assistance is needed, a face to face appointment or phone appointment will be necessary with Curative Care Center's Case Manager to determine eligibility. Safe and stable housing are elements that contribute to the overall wellbeing of an individual's compliance with treatment. In some instances, Curative Care Center is able to assist in temporary housing and assistance with utility bills, only when circumstances prove to be unavoidable or beyond a clients control. To determine eligibility, the client will be required to provide current income, expenses, and other financials. If client refuses to do so or provides false/fraudulent information, Curative Care Center has the right to decline further financial assistance. The timeframe in which Curative Care Center is authorized to provide temporary housing is on a case by case basis and evaluated regularly. The client must be willing to work toward financial solutions and utilize resources responsibly.

Non-compliance is an automatic discharge from our program. Curative Care Center has the right to decline additional financial assis5tance beyond basic medical, transportation, and medications. It could take up to 14 days for review and approval. Eligibility for program will be reviewed every 3-6 months.
